



CC meeting on May 1 – As usual, this meeting generated several topics that will be treated in separate articles below. My thanks to Bob Edwards for taking notes to fill the gaps in my hearing.

Pets in recreational areas – By FV Rules, they are not allowed, but there are legal exceptions. Do not confront someone you think is in violation. Notify Security and they will handle the situation.

Promotion in the Office – Penny Underwood has been named Office Administrator & Coordinator. She will continue to serve as Contracts Coordinator. Our recently hired Escrow Clerk is no longer with us. Restructure and/or replacement is being considered.

Leash law – FV has a rule that leashes should be no longer than six feet. That rule has been ignored and unenforced for years. No more! Because of two recent dog bite incidents that involved extendable leashes, Security will be giving warning and citations to violators. A word to the wise ...

Charging of electric vehicles – Each assn will have to have its own rules, but one rule needs to be common to all. There can be no cord running across sidewalks or other walking paths.

New rules for estate sales – Not yet, but coming soon. The Committee for Estate Sales formed last month met and created a new set of rules defining when and how estate sales are to be conducted in FV. The result was presented to the CC. As expected, some changes were suggested by the CC delegates, so the committee will meet again and present a revision next month.

The end of Open Forum? – Keith Pierce, the recently elected chair of the CC, pointed out that the CC Bylaws make no mention of an “Open Forum”. In fact, the only way a non-delegate can speak at the meeting is to make a request at least a day ahead of time and get permission from the chair. It appears that, unless the Bylaws are amended, the Open Forum will be a thing of the past. At least one delegate expressed agreement with the chair. On the other hand, at least one non-delegate expressed opposition, saying that there would be little incentive to attend and observe if there were no opportunity to speak. One observer suggested that the Open Forum could be conducted after the official CC meeting has adjourned. Responding to that idea, the chair was heard to say, “After the meeting I’m out of here”. It should be noted that the Bylaws of the Rec Assn also make no mention of the Open Forum. If it is eliminated in the CC, what will happen in the Rec Board meeting? It seems that the only sure way to keep the Open Forum is by amending the CC Bylaws. The procedure for doing that is actually very simple. It takes a

motion and an affirmative vote by the delegates present at any official CC meeting. No mailing of ballots is required, and the only advance notice is the normal one of putting the topic on the Agenda posted four days before the meeting. The Open Forum is the only means a “normal” person in FV has of expressing an idea and having it heard by a large number of fellow owners. If you believe it is important to keep that facility, then contact your own Board and ask them to be prepared to discuss and vote for retaining the Open Forum
