Renovation Update

Ballot to Vote Process

Many may not understand the ballot to vote process. It is a major effort and cost to any Rec Board. After all of the contractors are contacted, proposals received, reviewed and revised; after all of the forethought and letters are painstakingly created; after target dates are set and the envelopes are stuffed and mailed; and after the 30 day window passes and the Election committee is tasked... your votes are counted.

But did you know...IF less than 440 ballots are returned, that the election is null and void? All of the effort, for all of those weeks and months; all of the expense and all of the volunteer hours become useless and wasted because of those who didn't take the time to cast a vote.

Your vote represents 1/1290th of this community and it is desperately needed to assure us that the efforts we put forth, on your behalf, are not without purpose. Homeowners, please VOTE! If you own more than one property, PLEASE VOTE on every ballot for each home that you own... Renters...please urge the landlord who owns the property to VOTE! If you swim, PLEASE VOTE! If you know someone who loves to swim, someone who rehabilitates in the water, someone who watches their grandchildren enjoy our pool...PLEASE VOTE!!! Thank you to those who do...

Information Re: Volunteering for Election Committees

Each Association holds its Annual Meeting and <u>Elections</u> separately, which means we need 14 separate Election Committees. Volunteers may, and are encouraged to, volunteer for more than one date.

For those of you who have not participated as a volunteer before:

The Recreational Association is the first to hold its Election meeting on Monday, 10/19/20. Because of its size, 9 volunteers are needed. This meeting requires more time than described below because it involves all Friendly Valley Homeowners (1,290).

The meetings for each of the other Associations usually take a total of about one and a half hours of a volunteer's time. It involves first sitting with the other volunteer committee members at a table in the Auditorium (or other meeting location) for possibly 30 – 45 minutes to receive ballots that have not been previously turned in and to register those homeowners attending. The committee then retires to a separate room and will spend maybe another 45 minutes opening and counting the ballots.

Mary Jane Hartman has volunteered to make calls to set up committees. She has access to the list of volunteers from last year and will be calling those, as well as other names that have been suggested as possible volunteers. You do not have to wait to be called; if you're interested in volunteering, please call the Business Office with your name and phone number and the information will be passed on to Mary Jane. When you speak with Mary Jane, *if you feel you can do more than one meeting*, please let her know.

In the event COVID-19 is still an issue by October (and provided complete quarantine has not been mandated):

We will use fewer committee members and seat each committee person 6 ft. apart at each phase of the Election process. Masks and gloves will be required for committee members. Homeowners attending the meeting will be asked to wear masks and to stand back from the Registration Table at least 6 ft. Every effort will be taken for all phases of any Association's meeting date to ensure everyone's safety. If the meetings cannot be held, the Election Committee will be positioned at a table outside, possibly located in the vicinity of the Business Office, in order to open and tally Ballots.
